A) CASCO TOWNSHIP PARKS AND RECREATION MASTER PLAN

Planner Cassin reported that Recreation Plans are required in order to apply for and obtain any grants. Acquisition, development, improvement grants are possibilities. Plans are good for five years and are specific as to what is placed in the plan. Plan must be approved by the Township Board by March 1, 2017. Population, demographics are discussed in the plan based on 2010 Census.

Supervisor Ruemenapp forwarded a PDF to St. Clair County Parks and Recreation, Mark Brochu, and only input received is Casco Township needs to address the trail from Gratiot to 32 Mile Road. Planner Cassin will contact Mark Brochu in order to include this in the proposed Recreation Plan. The Township Board will act on this in February. Township was contacted about a donation contiguous to the property being purchased. Conservancy believes it may be melded into the purchase grant.

Supervisor Cassin reviewed all aspects required in the Recreation Plan. Currently the township doesn't have any active park land. Chapter six of the Parks and Recreation Master Plan is the planning process, and states a minimum of two ways of taking public input. A survey and public comments is what Casco Township has chosen. 49 survey responses were received. The request for the grant matches what the survey responses reflect. Must provide a concept plan of what the park would look like. Goals and objectives are included in the Recreation Plan, which mentions coordination with the County's Recreation Plan. The Recreation Plan must include the public hearing notice, action by the Board approving the Recreation Plan and the survey.

A motion was made by Member Goulston, supported by Member Edwards to recommend to the Casco Township Board the approval of the Casco Township Parks and Recreation Plan subject to changes delineated by the St Clair County Recreation Department.
